I am directed to refer to your letter No.ख०आ०प्र००५/court-1/2016/2086 dated 31.05.2016 on the above mentioned subject and to say that the request of the State Govt. has been considered and it has been decided to allocate a monthly quantity of 48236.51 tons per month comprising of 42775.634 tons of rice at MSP derived rate and 5460.876 tons of wheat at MSP rate to Jharkhand from June, 2016 to September, 2016 to enable the State Govt. to meet its additional requirement of foodgrains for drought relief.
